

The Bellingham Police Department is providing this bulletin to inform you of a Level III Registered Sex Offender living in the 2400blk of Pacific St. This bulletin is not meant to shock or alarm but rather to provide relevant information regarding this offender, his criminal history, and his potential threat to our community.

Nowakowski was convicted of Rape in the 1st Degree while residing in Sallisaw, Oklahoma. His victim was a juvenile male who was mentally disabled. He has additional convictions for burglary, communication with a minor for immoral purposes, theft, auto theft, and furnishing liquor to minors. Psychological evaluation indicates that Nowakowski has a pattern of homosexual pedophilia which has a very high risk of repeat

Bellingham Police have rated Nowakowski as a Level III Sex Offender based on the seriousness of his offenses and his high risk of re-offending.

The Bellingham Police Department is providing this bulletin to inform you of a **LEVEL III REGISTERED SEX OFFENDER**, **Kevin Noonan**. This bulletin is not meant to shock or alarm, but rather to provide relevant information regarding this offender, his criminal history, and his potential threat to the citizens of Whatcom County.

Noonan is a Level III Sex Offender who is predatory and dangerous. He arrived in Bellingham on January 29, 1998 and is currently living on the streets in the downtown area of Bellingham. He has a conviction for Child Molestation 1st Degree. He has been sexually assaulting children since the age of 13 and has a well established pattern for stalking young females at playgrounds, malls, parks, schools, and churches.

Noonan participated in Sex Offender Treatment while in custody. The treatment was not considered successful by his counselors who identified him as a high risk, sexually violent, predator.

He has been classified as a Level III Sex Offender based on his past criminal history, his failure to be amenable to treatment, and for his predatory nature.
